You must be a U.S Citizen, a resident of Oglethorpe County, 16 years of age or older, a registered voter, able to write and speak the English language and have no prior felony convictions for at least 10 years and have basic computer skills. In addition, the poll office is expected to assist with polling place setup, assembly of voting booths and deal with the public in a courteous, patient, and efficient manner.

Training Classes

Training is provided prior to each Primary Special, and General Election on the use of voting equipment, procedures and specific duties. Classes are 2 hours.
